2021 was a busy year for Flint Ridge. We got past the worst of the Covid pandemic and things started returning to normal. The summer season was busy as we had a great season for our floating, rentals, camping and golf. We continue to see a lot of interest in people asking about Flint Ridge and new property owners buying places here. Several new homes are under construction and one was recently finished. We receive multiple calls weekly from people inquiring about building new homes in Flint Ridge. It is exciting to see and hear all the buzz about our resort.

Over the past year many projects have been completed or are currently being worked on. Crossroads was repaved from the construction gate to the fire department. Hot patch was laid out to fill many of the pot holes and bad areas on the roads. The contractor will be repaying South Flint Ridge Dr from the stop sign to the road going down to canoe pick up. They will also be doing work on the road out to Indian Springs area. LED lighting has been installed at the recreation area, main gate and 412 gate. The dock at Clear Lake has been redone and picnic tables have been added. All the picnic tables have been repaired and repainted for the recreation area and Sycamore Park. The bath houses at Sycamore Park are currently being remodeled and will be ready for the upcoming season. Repairs have been done to the exterior of the administration building and a new staircase built on the East side of the building. The office pool has been converted to a salt water pool.



We will be installing new street signs that will be easily visible making it easier to find roads in Flint Ridge. This will be a multiyear project because of the number of roads. This year the signs from the construction gate and 412 gate to the fire station and Flint Ridge drive to South Flint Ridge Dr will be replaced. Our new website is up and running. You can pay your dues online and manage your account. There is also a calendar showing the clubhouse and rental

schedules and when they are available. With this website we have switched our alert system over to coordinate with the website. You can go to the website to sign up to get the alerts. This will allow us to provide more information since we won't be restricted in the number of words we can use.

As our summer season is quickly approaching, we would like to remind everyone to watch your speed as there will be more people out walking and riding bikes on the roads. The posted speed limits are 25 mph on the paved roads and 15 mph on the dirt roads. Remember that golf carts, ATV's and side-by-sides are only allowed on designated roads and in the stump dump area. Riding on common areas, the sides of the road or trails that are not in the stump dump area will result in a citation. We are looking forward to the upcoming season and hope all our members and their guest have a wonderful summer.

GRDA SCENIC RIVER PERMITS

Did you know that all flotation devices going on the Illinois River require a yearly permit from GRDA Scenic Rivers? The permits are \$10 each with a \$1 convenience fee and can be purchased at the Flint Ridge POA office. We have a limited supply, so get yours while they are still available. Permits should be placed on the front right side of vessel.

GATE CARDS AND GUEST ACCESS

There seems to be some confusion on guest access and gate card usage. Guidelines can be found on our web site under corporate documents.

Guest access is thru the Security/Crossroads gate only. Even if they have a pass or have been called in. Owners may accompany their frequent guests to the POA office & purchase a

gate card for up to 5 guests (this includes green passes). If you have any questions, please call the POA office and we will be glad to answer any questions you may have.

FROM YOUR WATER DEPARTMENT

Believe it or not the New Water Plant turned 2 yrs. old this past December, which means the reduced water rates we have been enjoying since Jan. 2020 will be coming to an end at the beginning of 2023. This was part of the lease agreement the POA made with the newly formed SDCRWA. The SDCRWA Board of Trustees will vote on the final numbers in the next couple of months, and it will then go into effect on the Jan. 2023 billing cycle, so you still have about eight months at the current rates.

Your base rate will likely go back to the \$34.75 it was, though this will ultimately be up to the Board to determine & you will also be paying for the 1st thousand gallons again as well, at that same time. The

current rate per thousand will also increase to match the Wholesale Rate and will only increase after that if & when that wholesale rate is raised, this is also part of the POA Lease Agreement. That rate is \$4.64 per thousand up slightly from the current \$4.52 you now pay.

We are currently working to replace portions of the water line supplying S. Flint Ridge Dr. in preparation for the line extension that the Cherokee Nation is paying to have installed to supply water to homes on Chewey Rd.

This added usage will help ensure that the cost per thousand gallons stays low and any necessary increases will be small.

At this past POA Board meeting we agreed to re-open Val-

ley View Rd. to thru traffic, but only during daylight hours. We are also moving the gate near W. Clear Creek Rd. back to the end of our lagoons to allow access to the cave near there. The gates, which are being built for us to replace pipe gates we now have. We will be open the gates from dawn to dusk each day, and please remember we have heavy equipment being pulled on trailers as well as chemical trucks coming and going for the plant.

If you have any questions, please call. Our posted hours are Mon. thru Fri. 7-12. We are in and out most afternoons, but we can always schedule a specific time to be in the office if afternoons work better for you.

FLOAT TRIPS

Friday, May 27th kicks off our floating season. Float trips are available Fridays, Saturdays and Sundays thru Labor Day Weekend. Also Mondays, on May 30th, July 4th and September 5th. We offer rafts, single and double kayaks and canoes. Rafts are \$65 with a maximum of 5 people per raft and kayaks and canoes are \$17 per person.

Please note—-Launch times and pickup times have changed for this year.

Launch times are 10:00, 11:30 and 1:00

Pickup times are 1:30, 3:00 and 4:30

(Each vessel not back by 4:30, will be charged \$50 for being late)

Remember launch times are when the bus leaves the

office area, not when you sign up. All floaters should be signed up 15 minutes before launch time and be in the bus loading area. Floaters not signed up and in the bus loading area 15 minutes before launch are not guaranteed to go at their reserved time. We recommend making reservations, as floats book up fast and we may not have any vessels available for walk-ins.

There are a lot of dogs running freely around Flint Ridge. The fine is \$50 for the 1st offense & fines double each time thereafter. Fines will be added to owners POA account.

The 1st & 3rd Thursdays of each month beginning at 5:00 p.m. will be adults 21 and over only at the clubhouse pools.

CONVENIENCE FEE

POA dues paid with a debit or credit card are now charged a 3.5% convenience fee

The Annual POA Meeting and Board of Directors election will be held on Saturday, May 28th at

current as of May 11th, 2022 to vote! Gate Cards will be required for identification to receive ballots. Voting is 1 ballot per lot.

Ballots will be available upon request, at the POA office beginning May 12th. Requests for absentee ballots can be made in person, by telephone, or email. Ballot request by phone or email will be mailed to owners and must be

mailed back to the POA office. All absentee ballots must be received in the POA office no later than 48 hours (May 26th by 9:00 a.m.) prior to the election in order to be counted.

This is a formal letter declaring my desire to run for a fourth term on the Flint Ridge POA Board of Directors. I am currently serving as Secretary (6 terms); I also served two terms as President.

My wife and I have been property owners since November 1980. All of the properties we are responsible for are located in Block 19 on or near South Flint Ridge Drive. We have built a personal house and garage, and we spend about 2/3rds of our weekends at Flint Ridge. I am the founder and president of Petra Field Camps, owners of Meyer Log Cabin and the Hall House near our personal house.

I am an emeritus (retired) professor of earth science and geography at Oral Roberts University, where I taught from 1967 to 2015. During the past 40 years Flint Ridge has been an invaluable teaching resource during hundreds of day and overnight field trips for ORU students. Meyer Log Cabin was built primarily to serve the ORU community, but we now host diverse church groups and families, often bringing visitors to Flint Ridge for the first time.

My goals for Flint Ridge are unchanged:

- 1) Stability for the present, and long-term sustainability, with reasonable growth. We need consistent and stable leadership, finances, and policies, and to enlarge our ownership base. We especially need new houses, which I try to support vigorously.
- 2) A family friendly resort that protects and enhances the reasons many of us purchased property here. I am especially interested in the value of Flint Ridge for children, for whom Flint Ridge can be a nearly ideal environment.
- 3) Protection and enhancement of our unique Ozark Forest. There is nothing like Flint Ridge until well into Arkansas. I have the same goals for our land as those of The Nature Conservancy, which strives to preserve habitat for wildlife. I support efforts to improve the accessibility and educational value of the common lands and hiker easements at Flint Ridge. I also support efforts by the Oklahoma Scenic Rivers Commission to protect and enhance the water resources in the Illinois River.
